Summary:

Jim joined the U.S. Army at the age of 18, serving 3 years, receiving an Honorable Discharge with the rank of E-5, Good Conduct Medal and an ARCOM medal. He then served eight years as a police officer where he earned a B.A. in Criminal Justice. Jim then joined the Armored Car industry as a supervisor where he earned a Master's in Management, serving 26 years (22-Brinks' and 4-Loomis) with a total of 20-years in senior level field positions of Area General Manager, District Manager and Regional Director/Regional Vice President. Jim had full P&L responsibility ranging from \$40 to \$100 million with direct reports: Loss Prevention Managers, Human Resource Managers, Account Executives, Branch Managers, Financial Controllers, District Managers, Transportation Managers, Coin Managers, Currency Processing Managers, ATM Managers, and Training Managers.

During his 26-year tenure in the security/logistics/transportation industry, he was responsible for managing and protecting assets at 50 high risk facilities, several thousand armed-guards and 1,000 armored vehicles. It is his profit & loss experience that separates Jim from other security consultants and helped him realize the importance of recommending cost effective security measures to mitigate risk and balance security with profits.

Jim has been interviewed on security loss events by CNN, ABC, New York Times and other Canadian and US news media and publications. He is considered a global expert in the security risk assessment process and is VP Charleston Region and Board Member for South Carolina Infra-Guard, an FBI sponsored organization where critical infrastructure private sectors share best practices to protect against terrorist and criminal attacks.

Jim is one of approximately 200 security professionals world-wide to hold all three ASIS Board Certifications in Security Management, Physical security and Investigations which are accredited by the Department of Homeland Security, International Standards Organization and American National Standards Institute.

Jim has served as staff and lead instructor for 55 Antiterrorism Administration Assistance (ATA) courses, training federal, state, local law enforcement and private security professionals in the following countries, visiting many on multiple occasions: Afghanistan, Egypt, Columbia, Jordan, Mexico, India, Tajikistan, Kazakhstan, Uganda, Pakistan, Philippines, Tunisia, Jamaica, Qatar, Chad, Niger, Mauritania, India, Senegal, Argentina, Indonesia, Yemen, Libya and Saudi Arabia Kingdom.

As part of the ATA Program, Jim has supervised security risk assessments in the aforementioned parts of the world at the following facilities: Water Treatment Plant, Railway Stations, Bus Terminals, Electric Power Plants, Hotels, Malls (13 stories), Hospital, Sports Stadiums, Secretary of Energy facility, Secretary of Interior facility, Military Training Centers, Department of Interior facility, National Police Headquarters, a Government School (ages 5-18), a Mosque, Churches, a National Art Museum, Airports, A Commercial Shipping Pier, A Police College, an International Expo Center and numerous government critical infrastructures.

This standard provides guidance on developing and sustaining a coherent and effective risk assessment program including principles, managing an overall risk assessment program, and performing individual risk assessments, along with confirming the competences of risk assessors and understanding biases.

2014-2017 Served as Committee Chair for Houses of Worship under the ASIS International Cultural Properties Council which he has been a member since 2012. Prior to serving on the Cultural Properties Council, Jim also served on the ASIS International Physical Security Council from 2012-2014.

April 2015 Hired by General Dynamics Technology as one of four Subject Matter Experts to rewrite the Vital Infrastructure Course for Department of State used to train law enforcement officers in the Vulnerability Analysis Methodology to protect vital infrastructure from terrorist attacks. This new course which became effective July 2017 was renamed Critical Infrastructure and Security Analysis. Jim recommended adding a module which focuses on detecting hostile surveillance. Jim also serves as a lead instructor on the Surveillance Detection Course and in 2016 began sharing the importance at ASIS International and other international, national and regional-security forums of having hostile surveillance detection training as a security strategy for all facilities to prevent terrorist and criminal attacks.

Certifications:

As noted above, Jim is one of 200 security professionals globally to hold all three ASIS International Board Certifications in Security Management. A Board-Certified Designation is acknowledged as the security profession's highest recognition of practitioners. Rather than the individual stating qualifications on a CV or resume, the individual's experience and education are verified and reviewed by a professional board of his peers and once qualified, the candidate is tested in the area of expertise selected and must receive a passing score. Testing is monitored under camera and with supervisory personnel present at all times.

The CPP®, PSP® and PCI® certifications are awarded based upon experience, education and examination that provides objective measure of an individual's broad-based knowledge and competency in security management, physical security and the investigation process. Ongoing professional development is required to maintain each credential. The CPP®, PSP® and PCI® are administered by ASIS International, the preeminent international organization for security professionals, with 38,000 members worldwide which Jim has been an active member since 1981.

Jim's board-certifications in security are accredited by the Department of Homeland Security, American National Standards Institute and the International Standards Organization 17024 Standard. In addition, these certifications have been awarded the DHS's SAFETY Act Designation, which gives ASIS board-certified professionals, their employers, and their customers immediate protection from lawsuits involving ASIS certification and the ASIS certification process that arise out of an act of terrorism.

Certified Protection Professional (CPP®) – This certification designates individuals who have demonstrated competency in all areas constituting security management.
